

## INVITATION TO BID

The Pawtucket Housing Authority, Pawtucket, Rhode Island, the Awarding Authority, invites sealed bids from Contractors for completing elevator modernization at Fogarty Manor, RI 2-4 and Kennedy Manor, RI 2-3,5 in accordance with the documents prepared by William Starck Architects, Inc., 126 Cove Street, Fall River, Massachusetts.

The work generally includes, but is not limited to the following:

Modernization of elevator components of four (4) elevators in total (2 per building). Fogarty Manor is a fifteen (15)-story building and Kennedy Manor is a nine (9)-story building. Components include, but are not limited to new controls, hoist machines and deflector sheaves, governors, car frames and safety systems (roller guides, slings, platforms, and elevator safeties), counterweight frames, counterweight plates, hoist ropes, car and hoistway door equipment, cab enclosures, car and hall station fixtures, traveling cables and hoistway wiring, buffers and pit equipment, including cleaning of guide rail supports. Work also includes incidental electrical, lighting, and fire alarm system upgrades, and mechanical heating, cooling, and ventilation upgrades. **Refer also to Section 00500.1, Elevator Service Contract.**

Bids are subject to Equal Employment Opportunities, bonding requirements and other bidding and contract requirements as set forth in the construction documents.

Bids will be received until **10:00 A.M. on Monday, March 23, 2026**, at the Pawtucket Housing Authority, 214 Roosevelt Ave, Pawtucket, Rhode Island, 02860, at which time they will be publicly opened and read aloud.

Bids shall be accompanied by a Bid Bond that is not less than five percent (5%) of the bid amount.
